Gabe is an Indigenous rights attorney and the managing lawyer at Galanda Broadman. His practice focuses on complex, multi-party litigation and crisis management, representing Indigenous nations, businesses and citizens. He has been named to *Best Lawyers in America* in the fields of Native American Law and Gaming Law from 2007 to 2022, and dubbed a Super Lawyer by his peers from 2013 to 2022.

Gabe is skilled at defending Indigenous nations and business against legal attack by governmental or private parties, as well advocating for the human rights of Indigenous American citizens. He advocates against tribal disenrollment and citizenship rights violations, as well as other domestic Indigenous human rights abuse, including law enforcement violence. He also assists Indigenous clients with transactions and strategy related to various economic diversification initiatives.

The American Bar Association awarded Gabe the Spirit of Excellence Award in 2022 and named him a Difference Maker in 2012. The Washington State Bar Association honored him with the Excellence in Diversity Award for his "significant contribution to diversity in the legal profession" in 2014. For his staunch disenrollment advocacy, the University Arizona College of Law awarded him the Professional Achievement Award, and Western Washington University named him a Distinguished Alumnus, in 2018. The University Arizona College of Law also named Gabe its 2022-23 Alumnus of the Year.

Indian Country Today honored Gabe as one of "five people are rocking the world with their forward thinking, innovation and commitment to social justice" in 2013, and as one of Fifty Faces of Indian Country in 2017. In 2009, the National Center for American Indian Enterprise Development honored him as Native American 40 Under 40. He has also received the Native Justice Award from the Northwest Indian Bar Association.

Gabe writes frequently about Tribal Treaty and sovereignty rights and Indigenous human rights issues, having been published over 100 times in such other national periodicals as *National Law Journal*, *Business Law Today*, and *Gaming Law Review & Economics*. Most notably, he coauthored a law review article titled, "Curing the Tribal Disenrollment Epidemic: In Search of a Remedy," which was published by *Arizona Law Review* in 2015.

He also often lectures about Indigenous human rights issues at universities and law schools, having talked at Harvard University and Yale, Cornell, Berkeley, Arizona, and Kansas law schools.

Gabe is a frequent media commentator as well, having been interviewed and quoted by mainstream and international news outlets such as *The New York Times, Wall Street Journal, The Guardian*, and *Le Monde*.

In his "spare time," Gabe founded and now operates Huy, a 501(c)(3) tribal non-profit organization dedicated to enhancing religious, cultural and other rehabilitative opportunities for Indigenous prisoners. Serving as Chairman of the Huy Board of Advisors, he has led the organization's amicus curiae efforts before the U.S. Supreme Court and federal and state appellate courts across the country as well as the group's human rights advocacy efforts before the United Nations.

Gabe belongs to the Round Valley Indian Tribes of California, descending from the Nomlaki and Concow Peoples.

Over the course of his legal career, Gabe's community service and philanthropic accomplishments include:

- Catalyzing the National Congress of American Indians' passage of Resolution #20-001, which authorized the formation of the Tribal Citizenship Policy and Protection Task Force in 2020.
- Leading the reform movement in Washington State that caused the state Department of Corrections to, by 2012, restore all of the Native American prisoners' religious rights that it had divested through regulatory changes in 2010. For his hundreds of hours in related pro bono publico service to Native American prisoners, Gabe has repeatedly received commendation from the Washington State Bar Association since 2010.
- Authoring and presenting a paper, "American Indian Treaties: The Consultation Mandate," and otherwise providing the American Indian treaty and human rights perspective, to the United Nations Office of the High Commissioner on Human Rights at the Palais de Nations in Geneva, Switzerland, in 2012.
- Spearheading the inclusion of federal Indian law on the Washington State bar exam, which, in 2004, became the second of three states in the country to test the legal acumen of new lawyers in regard to that subject matter. That effort resulted in Gabe's receipt of the WSBA Young Lawyers Division's Outstanding Young Lawyer Award that same year.
- Founding and administering the Indian Legal Scholars Program, a joint venture between the Northwest Indian Bar Association and WSBA Indian Law Section, which by 2010 raised and donated over \$125,000 in scholarship monies and bar stipends to aspiring Native lawyers. While Gabe chaired the Indian Legal Scholars Program, it was honored for making a difference in the legal profession by the American Bar Association in 2004.
